ENGINEERING DAY AT THE STATE CAPITOL JANUARY 31, 2024

ACEC, ASCE, MSPE and APWA are planning the 2nd annual Engineering Day Event in Jefferson City at the Capitol Building. This will be similar to what other occupational organizations do (doctors, law enforcement, teachers) to build relationships with lawmakers, providing them resources for policy decisions that affect us. More details to come soon.

LEGISLATIVE UPDATE

The Missouri Broadband Office's recently released *Five Year Plan* document outlines how Missouri will use \$1.7 billion in <u>BEAD</u> program funds to expand internet access. The broadband office is requesting that municipalities report the address and internet speeds of their community anchor institutions using the University of Missouri's <u>collection survey</u>.

<u>Missouri 911 dispatchers now qualify as first responders.</u> A bill Missouri Gov. Mike Parson signed into law in July gives dispatchers access to expanded benefits, including mental health care services and earlier retirement, by defining them as first responders and allowing jurisdictions to do the same. Qualifying Public Works employees as first responders is on our radar for future possible Missouri legislation.

Office of Management and Budget's final <u>Build America, Buy America guidance</u> is helpful for infrastructure projects receiving federal financial assistance.

The Department of Labor has published the final rule updating the <u>Davis-Bacon labor standard</u> regulations, which set forth the rules for the administration and enforcement of the Davis-Bacon labor standards for federal and federally assisted construction projects.

The House and Senate convened to consider the 201 line-items eligible for consideration for Veto override. Members did make motions to override certain line-items; the Section 19.303 for the planning, design, land acquisition, utility relocation and construction of capacity improvements on I-44, Section 19.504 for the planning, design and construction of a police center in St. Louis City. The overrides were sent to the Senate for their consideration. The Senate did not take action on any overrides, leaving Governor Mike Parson's budget cuts in place.

DEI UPDATE

What is a gender pronoun?

In the English language, gender pronouns are gender identifiers when referring to a specific individual in the third person. In the past, gender pronouns were separated into masculine (he/him/his) and feminine (she/her/hers) categories. Using only masculine and feminine pronouns is called gender binary and only recognizes men and women. However, many people identify outside of this gender binary. Gender-neutral or nonbinary pronouns such as they/ them/theirs or xe/xer/xers (ze/zir/zirs) allow people to use

pronouns they feel are more suited to their identity. The terms "it" or "he-she" are slurs used against transgender and gender nonconforming individuals, and should never be used.

Why do pronouns matter?

A person's outward appearance or name will not always indicate their gender. Therefore, it is important not to make assumptions based on them. Just like a person's name, a pronoun is connected to identity. If an incorrect pronoun is used it can make someone uncomfortable and possibly even marginalized or isolated. Using the correct pronouns fosters respect and inclusivity.

What can I do to be more inclusive?

- Use someone's personal pronouns if they have shared them.
 - If someone has not shared their personal pronouns you can ask them.
 - "What pronouns do you use? "
 - "What are your personal pronouns?"
- If unsure, use a person's name instead of a pronoun.
 - For example if someone asks if you know Chris from the KC Metro Chapter you could respond *"No, I do not know Chris."*
- If you do not know a person's gender, pronouns, or name then use descriptive gender neutral language to refer to them.
 - "Please give that flyer to the person in the red shirt standing by the door."
 - Add your own pronouns to your email signature and LinkedIn page.
- Gently correct someone if you know they have used an incorrect pronoun.
 - "Actually, Steph uses they/them pronouns."
- Use nametags with a space for pronouns or provide optional pronoun stickers at events.
